 - 2) Trainees must achieve at least 75% attendance and have sat for all examinations. Course fees must be fully sponsored by the company that is registered or incorporated in Singapore
- **SkillsFuture Credit**
 - 1) Trainees must be Singaporeans aged 25 and above in 2016 to receive the SkillsFuture Credits from the Government
